### **Objectives of the Committee**

3. To promote a safe, respectful, and positive academic atmosphere.
4. To encourage students to follow institutional rules, regulations, and code of conduct.

### **Powers & Responsibilities**

- To review and address disciplinary complaints in a fair, impartial, and confidential manner.
- To call students involved in disciplinary matters and obtain statements from concerned persons and witnesses.
- To recommend appropriate corrective or disciplinary measures such as counselling, warning, undertaking, suspension, fine, or other action, depending on the nature and severity of the matter and as permitted under institutional and applicable University rules.
- To coordinate with the concerned committees, authorities, and Principal wherever necessary.
- To submit reports and recommendations to the Principal.
- To maintain proper records of disciplinary proceedings and actions taken.

## Approval

The resolution was read, discussed, approved, and adopted by all members present without objection. The reconstituted Committee shall come into effect from **05-08-2026** and shall continue to function until further orders.

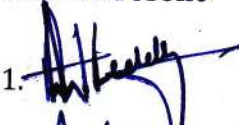

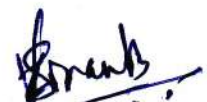
